REGULAR CITY COUNCIL MEETING

1. CALL TO ORDER AND ROLL CALL

Mayor Davis called the meeting to order at 6:30 p.m. In attendance in addition to Mayor Davis, were Mayor Pro Tem Lydia Bryan-Valdez (Zoom), Councilmembers, Candace Blake, Tony Valdez, Dr. Gayle Hudgens, Attorney Josh Katz (Zoom), City Engineer Don Rauschuber (Zoom), and City Secretary Cynthia McCall.

3. PUBLIC COMMENTS

4. **NEW BUSINESS**

a.) Receive and take appropriate action to approve the September 2024, financial report.

b.) Take action to approve the minutes for September 9, 2024

Motion was made by Councilwoman Hudgens to approve the September 2024, financial report and was seconded by Councilwoman Blake. Motion carried unanimously.

c.) Take action to sponsor a fall clean-up day.

Councilwoman Blake nominated Tom Lemman, who is actively involved in the community to fill the vacant seat on the city council. Councilwoman Hudgens seconded the motion and the Council voted 4-0 and he was sworn in as Place 5 on the Council.
